

## **ECONOMIC NEWS**

Bank of Botswana maintains the bank rate at 5% - The Bank Rate was maintained at 5 percent as decided at the Monetary Policy Committee (MPC) meeting held on April 24, 2019. The outlook for price stability remains positive as inflation is forecast to remain within the Bank's 3-6 percent objective range in the medium term. Inflation was unchanged at 3.3 percent between February and March 2019.

#### Turnstar Abridged Audited Financial Results for the Year Ended 31 January 2019

Turnstar has released full year results. Amongst the highlights was a 3% increase in revenue to BWP258.6 million (2018: BWP250.9 million). Profit before exchange difference and FV decreased 13% to BWP111.9 million (2018: BWP128.0 million). Net profit was 67% higher to BWP122.4million (2018: BWP73.2 million). The balance sheet grew 3% to BWP2.50 billion (2018: BWP2.42 billion). Investment property value rose 4% to BWP2.34 billion (2018: BWP2.25 billion). Basic earnings per linked unit were 21.21 thebe (2018: 12.79 thebe). A final gross distribution of 9.5 thebe per linked unit has been declared.

The Board of Standard Chartered Bank Botswana Limited (SCBBCL) has announced the appointment of Ms Doreen Cilla Khama as an Independent Non-Executive Director. She holds a Bachelor of Law Degree from the University of Botswana, Lesotho and Swaziland, certificates in Financing Small and Medium scale business, and Regulation and Development of the Financial Sector from the International Development Law Institute in Rome, Italy.
