

#### **COMPANY NEWS**

#### BTCL - Abridged Unaudited Financial Statements for the year ended 31 March 2019

BTCL has released full year results. Highlights include an 8% decline in revenue to BWP1.47 billion (2018: BWP1.59 billion). Gross profit decreased 10% to BWP889.5 million (2018: BWP987.1 million). Administrative expenses were down 4% to BWP422.9 million (2018: BWP439.7 million). Net profit declined 25% to BWP162.1 million (2018: BWP217.4 million). The balance sheet grew 6% to BWP2.58billion (2018: BWP2.43 billion). A final gross dividend of 5.73 thebe per share has been declared.

## BBS – Update for the Financials Audit for the year ended December 2018

Further to the update on 29 May 2019 to Shareholders, BBS Limited has advised that it has reviewed progress of the ongoing audit with its auditors KPMG and both parties have come to the conclusion that additional time is required to conclude the exercise.
